- Have budget authority and liability for Title I federal funds (\$4.1 million this year)
- Appoint the members of the Workforce Development Board
- Award contracts for service provision
- In conjunction with Board set vision, mission and strategic direction

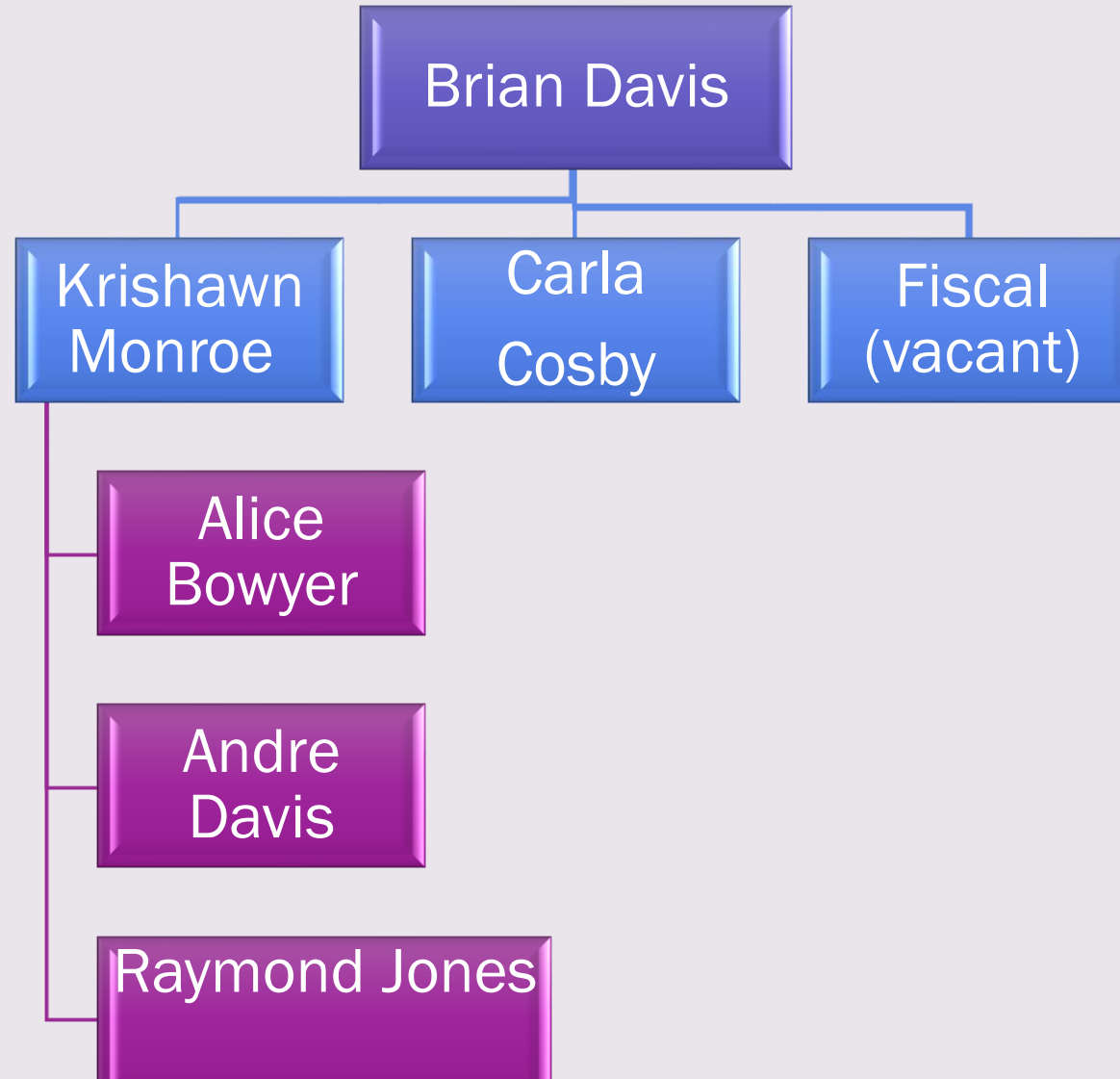
Workforce Development Board

- Business-sector majority and leadership
 - *Other required members from public sector*
- Selects service providers (with elected official consent)
- Develops budget for Title 1 funds (subject to elected official approval)
- Oversees and monitors the day-to-day work of the service providers
- Establishes policies for how Title 1 funds are used
- Establishes the one stop delivery system and enters into agreement with partners on what services they will provide and how they will make services available

Henrico County

- Receives and disburses federal funds on behalf of all 8 jurisdictions
- Provides the staff to the elected officials and workforce board
- Holds the leases for all three workforces centers
- Provides IT, fiscal, human resources, legal, real estate, procurement and facilities support
